



This manual contains instructions for installing and configuring the National Instruments GPIB-SCSI-A SCSI-to-GPIB Controller and NI-488.2 software for MacOS. This manual is meant to be used with the *NI-488.2 User Manual for MacOS* and the *NI-488.2 Function Reference Manual for MacOS*.

This manual assumes that you are already familiar with the Macintosh operating system.

How to Use This Manual Set



Use this getting started manual to install and configure your GPIB hardware and NI-488.2 software.

Use the *NI-488.2 User Manual for MacOS* to learn the basics of GPIB and how to develop an application program. The user manual also contains debugging information and detailed examples.

Use the *NI-488.2 Function Reference Manual for MacOS* for specific NI-488 function and NI-488.2 routine information, such as format, parameters, and possible errors.



Hardware Description

The GPIB-SCSI-A is a high-performance interface product that transparently handles data transfers between the SCSI and the GPIB. It is an 8-bit microcomputer that operates as a full-function IEEE 488/SCSI Controller. The GPIB-SCSI-A can transform any computer with a SCSI port into a GPIB Talker/Listener/Controller or make any device on the SCSI bus look like a GPIB device.

The GPIB-SCSI-A has all the software and logic required to implement the physical and electrical characteristics of the ANSI/IEEE Standard 488.1-1987 and the ANSI Standard X3T9.2. Also, all GPIB protocols have been updated to comply with ANSI/IEEE Standard 488.2-1987. It is able to interpret and execute commands that you send to it over the GPIB or SCSI ports and perform all necessary SCSI-to-GPIB protocol conversions.

Software Description

The NI-488.2 software for MacOS is a comprehensive set of programs and drivers that simplifies the job of programming the GPIB-SCSI-A to function as a GPIB Controller with complete communication and bus management capabilities. The NI-488.2 software also comes with an interactive debugger; FutureBASIC, Macintosh Programmer's Workshop (MPW) C, THINK C, and Metrowerks CodeWarrior C language interfaces; and a shared library for C programmers developing applications for PowerPC.


Optional Programming Tools

Your kit includes the NI-488.2 software for MacOS. In addition, you can order the LabVIEW software from National Instruments. LabVIEW includes instrument driver libraries that make it easier to communicate with your GPIB instruments.

LabVIEW is a complete programming environment that departs from the sequential nature of traditional programming languages and features a graphical programming environment. It includes all the tools needed for instrument control, data acquisition, analysis, and presentation. When you order LabVIEW, you also get hundreds of complete instrument drivers, which are modular, source-code programs that handle the communication with your instrument so that you do not have to learn the programming details.

Installation and Configuration



This chapter contains instructions for connecting your GPIB-SCSI-A, installing the NI-488.2 software, and testing the software installation.

If you need more detailed information, refer to Chapter 3, *Hardware Configuration*.

Connect the Hardware

The following are general instructions for connecting the GPIB-SCSI-A to your Macintosh. Refer to the manual that came with your computer for specific instructions and warnings.

You can use two methods to connect the GPIB-SCSI-A to your Macintosh. One method is connecting the GPIB-SCSI-A directly to the Macintosh computer by using a cable with the proper connectors at each end. The other method is daisy-chaining. *Daisy-chaining* is a means of connecting a number of SCSI devices to a host so that a single port on the host can serve a variable number of devices. If you are installing the GPIB-SCSI-A in the middle of a daisy-chain, you need to remove the terminating resistor pack. Refer to the *Using SCSI Terminating Resistors* section in Chapter 3, *Hardware Configuration*, for additional instructions for daisy-chaining SCSI devices.

There are four basic steps to connecting the GPIB-SCSI-A.

- 1. Shut down your system.
- 2. Connect the cables.
- 3. Switch on your GPIB-SCSI-A.
- 4. Power on your system.

The GPIB-SCSI-A is shipped from the factory with either a 100 to 120 VAC or 220 to 240 VAC power supply. Before you connect it, verify that the voltage specified on the rear panel label matches the voltage that is supplied in your area.



Caution: Operating the GPIB-SCSI-A at any voltage other than the one specified on the rear panel label could damage the unit. Replacement fuses must be the proper type and rating. See Appendix A, Hardware Specifications, for fuse information.

Step 1. Shut Down Your System

Complete the following steps to shut down your system.

- 1. Select the **Shut Down** command from the **Special** menu.
- 2. Turn off your computer.
- 3. Turn off all of the external SCSI devices, if any, attached to your computer.
- 4. Unplug the power cord from the power outlet.

Step 2. Connect the Cables

 \triangle

Caution: Never connect or disconnect SCSI cables when any device (computer, CD-ROM drive, GPIB-SCSI-A, and so on) is powered-on. Doing so can cause fuses to blow inside the GPIB-SCSI-A and inside other SCSI devices that supply termination power (TERMPWR) to the SCSI bus.

Complete the following steps to connect the cables.

- 1. Connect the SCSI cable to the GPIB-SCSI-A and fasten it securely. Connect the other end to your SCSI system. Be sure to use only shielded SCSI cables. Total cable length in your SCSI system should be less than 6 m, and terminating resistors should be installed on both ends as described in Chapter 3, *Hardware Configuration*.
- 2. Connect the GPIB cable to the GPIB-SCSI-A and tighten the thumb screws on the connector. Connect the other end to your GPIB system. Be sure to use only shielded GPIB cables. Total cable length in your GPIB system should be less than 20 m, with a maximum separation of 4 m between any two devices. You should have no more than 15 devices in a GPIB system, and at least two-thirds of those devices must be powered on.
- 3. Plug the power cord into an AC outlet of the correct voltage.

Step 3. Switch On Your GPIB-SCSI-A

Switch on your GPIB-SCSI-A by using the rocker switch on the rear panel. The **POWER** LED indicator should come on immediately and the **READY** LED indicator on the front panel should come on after the GPIB-SCSI-A has passed its power-on self-test, indicating that the unit is ready for operation.

If the **READY** LED does not come on within 10 seconds after the unit is powered on, recheck all connections and switch settings (refer to Chapter 3, *Hardware Configuration*) and try the power-on sequence again. If the **READY** LED still fails to come on, fill out the forms in Appendix C, *Customer Communication*, and contact National Instruments.

Step 4. Power On Your System

Plug the power cords of the Macintosh computer and any other SCSI equipment into a power outlet and power on all devices.

Install the Software

The NI-488.2 software is distributed in compressed form on one diskette. Installing all of the software requires about 1.5 MB of space on your hard disk and takes about five minutes.

NI-488.2 Software Components

The NI-488.2 software includes the following components:

- NI-488.2 Installer is the software installation program.
- NI-488 INIT is an INIT that loads the device drivers for installed National Instruments GPIB interfaces when you power on or restart your Macintosh.
- NI-488 Config is a control panel configuration utility that you can use to examine or change the software settings.
- NI-DMA/DSP is a system extension that provides DMA functionality through an RTSI connection to an NB-DMA2800 or NB-DMA-8.

- The C LI and BASIC LI folders contain language interfaces for Macintosh Programmer's Workshop (MPW) C, THINK C, Metrowerks CodeWarrior C, and FutureBASIC.
- MacGPIB.shlb is a shared library for C programmers developing applications for the PowerPC platform.
- IBIC 488.2 is an interactive GPIB control utility.
- NI-488.2 Test is a software diagnostic utility.
- IBDIAG NUBUS, IBDIAG PCI, and IBDIAG PCMCIA are hardware diagnostic utilities.
- The Ethernet folder contains utilities that are applicable only if you have a National Instruments GPIB-ENET.
- The Read Me file contains the latest updates and corrections to the manual when appropriate.

Install the NI-488.2 software by completing the following steps.

Step 1. Install the NI-488.2 Files and Folders



Caution: Virus detection software might prevent the installer from copying important files to the System Folder. You must disable or bypass any virus prevention software before attempting the installation procedure.

To install the NI-488.2 files and folders, complete the following steps.

1. Insert the NI-488.2 software distribution disk and double-click on the NI-488.2 Installer icon.

2. Click on the icon on the left side of the **Installer** window, shown in Figure 2-1, and drag it to any available disk on the right side of the window.




Figure 2-2. File and Folder Organization after Installation

After installation of all of the software, the NI-488.2 folder should contain the items shown in Figure 2-2. The installer places the NI-488 Config file in the Control Panels folder and the NI-488 INIT and NI-DMA/DSP files in the Extensions folder.

Step 2. Examine or Change the Software Settings

The default settings for the software work for most applications and devices. However, you might want to change a device name or primary address. Also, if more than one GPIB interface or external box is installed, you might want to associate a device with a particular interface.

NI-488 Config is a configuration utility that you can use to examine and change the software settings for your board. You can activate the configuration utility by selecting **Control Panels** from the **Apple Icon** menu and selecting **NI-488 Config**.

After the configuration utility is activated, click on the **Interface Type** menu and select **SCSI box products** as shown in Figure 2-3. Checking the **Auto Configure** box causes a scan over the SCSI bus to locate any GPIB-SCSI-A. An **x** appears in each SCSI ID box that corresponds to a GPIB-SCSI-A. If no boxes are checked, you might need to change a hardware setting. Refer to Chapter 3, *Hardware Configuration*, for instructions on changing hardware settings.

Step 3. Restart Your Macintosh

The NI-488.2 driver is installed every time you start or restart your Macintosh. The NI-488.2 software displays the National Instruments icon momentarily in the lower left corner of the screen to indicate that the driver is being installed. If the National Instruments icon does not appear on your screen, repeat the installation procedure before continuing to the next section, *Verify the Software Installation*.


Verify the Software Installation

This step verifies that the driver is installed and functioning with the GPIB-SCSI-A hardware. If any one of the software installation steps fails, you might have to change a hardware and software setting. If this is the case, refer to Chapter 3, *Hardware Configuration*.

Follow these steps to run the software verification test.

- 1. Disconnect all GPIB cables from the GPIB-SCSI-A box.
- 2. Double-click on the NI-488.2 Test icon in the NI-488.2 folder. If no error messages are displayed, the installation is complete.
- 3. If error messages are displayed, select **Restart** from the **Special** menu, and double-click on the NI-488.2 Test icon.
 - If the test fails again, reinstall the NI-488.2 software from the distribution disk, restart your Macintosh, and double-click on the NI-488.2 Test icon.
 - If the verification still fails, review the material in Appendix B, *Troubleshooting*, which describes how to troubleshoot problems and lists some common questions. If you need to change a software setting, refer to Chapter 6, *GPIB Configuration Utility*, in the *NI-488.2 User Manual for MacOS*.
 - If the software settings are correct and the verification still fails, carefully note all error information on the forms in Appendix C, *Customer Communication*, and contact National Instruments.

When the verification test is successful, you are ready to write your own application program. Refer to the *NI-488.2 Function Reference Manual for MacOS* for sample programs.



This chapter describes how to change the operating characteristics of the GPIB-SCSI-A and how to use SCSI terminating resistors.

The hardware configurations of the SCSI ID (Target ID) and the GPIB primary address must match the software configuration in the system configuration files and the NI-488.2 software for MacOS.

Configuring the Switch Settings

The GPIB-SCSI-A is shipped from the factory configured to operate in S (SCSI) mode. The SCSI ID to which the GPIB-SCSI-A responds is set at 5, and the primary GPIB address is set at 0. Additionally, the GPIB-SCSI-A is shipped from the factory with a SCSI terminator installed. To determine if you need to remove it, refer to the Using SCSI Terminating Resistors section in this chapter.

Note: The only switch settings available for configuration with this kit are the SCSI ID and the GPIB address, which are controlled by SW1. You do not need to change the switch settings for SW2, which controls the mode of operation.




Figure 3-1. GPIB-SCSI-A Rear Panel

Figure 3-1 shows the location of the switches on the back panel of the GPIB-SCSI-A.

Configuration Switch Settings for SW1

The DIP switch at location SW1 on the rear panel (see Figure 3-1) is used to configure the power-on primary GPIB address and SCSI ID of the GPIB-SCSI-A. The DIP switch has eight configuration switches.




Figure 3-2. SW1 Default Mode Switch Settings

Figure 3-2 shows the factory default setting of the GPIB-SCSI-A for switch SW1. Switches 1 through 3 are ON, OFF, and ON, respectively, selecting the SCSI ID of 5. Switches 4 through 8 are OFF to indicate that the GPIB primary address of the GPIB-SCSI-A is 0.

Configuration Switch Settings for SW2




Figure 3-3. SW2 Default Mode Switch Settings

The DIP switch at location SW2 on the rear panel (see Figure 3-1) is used to configure the mode of operation for the GPIB-SCSI-A. The GPIB-SCSI-A is configured at the factory to operate in SCSI (S) mode. In S mode, the SCSI port is the controlling interface. You do *not* need to change these switch settings for use with the Macintosh computer. The DIP switch has eight configuration switches. Figure 3-3 shows the factory default setting.

Make sure that these switches are set as shown in Figure 3-3. If they are not, set the switches as indicated.

Table 3-3 and the subsequent paragraph describe the factory default configurations of the eight switches.

Switch 8 is OFF, indicating that the GPIB-SCSI-A is operating in S mode. Switch 7 is ON, indicating that the GPIB-SCSI-A neither notices nor reports SCSI parity errors. Switch 6 is ON, indicating that the GPIB-SCSI-A buffers data during data transfer commands. Switch 5 is OFF, indicating that the GPIB-SCSI-A completes all data requests to the exact count specified. Switch 4 is ON, indicating that double buffering is used. Switches 1 through 3 are OFF because they are reserved.

Using SCSI Terminating Resistors

Because of its high-speed capabilities, the SCSI bus is sensitive to the electrical characteristics of the SCSI cabling. When a signal is sent through the SCSI bus, it bounces back and creates echoes along the cabling. Any devices in the middle of the daisy-chained SCSI bus receive these signal echoes. Placement of terminating resistor packs can prevent echoes and ensure proper termination of a signal. Proper termination is essential to the devices connected on a SCSI bus. Read the documentation for each device to find out what kind of termination it provides.




Figure 3-4 shows the GPIB-SCSI-A located at the end of a SCSI system.

If your GPIB-SCSI-A is located at the end of a SCSI bus, you can prevent echoes by leaving the terminating resistor pack installed on one of the ports on the rear panel of the GPIB-SCSI-A. Also ensure that the device at the other end of the SCSI bus (for example, the SCSI host in Figure 3-4) has a terminating resistor installed. But remove the terminating resistor packs on all devices except for the two at each end because SCSI signals are not reliably passed along the SCSI bus after they reach a device with a terminator.

Caution: Never connect more than two sets of terminating resistors on a SCSI bus, because more than two sets may overload the signals and generate errors.





Figure 3-5. Terminating Resistors for GPIB-SCSI-A Not at End of SCSI Bus

If your GPIB-SCSI-A is not located at the end of the SCSI bus, remove the terminating resistor pack from the rear panel of the GPIB-SCSI-A. Ensure that all devices in the middle of the bus (for example, the SCSI disk drive and the GPIB-SCSI-A in Figure 3-5) do not have terminating resistors installed. The devices at each end of the SCSI bus should have terminating resistors installed.

Figure 3-5 shows the GPIB-SCSI-A at a location other than the end of a SCSI system.



Troubleshooting



This appendix suggests some areas to check if you have problems installing the GPIB-SCSI-A or the NI-488.2 software after going through the procedures described in Chapter 2, *Installation and Configuration*, and Chapter 3, *Hardware Configuration*.

If you still have problems after completing the steps in this appendix, complete the appropriate forms in Appendix C, *Customer Communication*, and then contact National Instruments for technical support.

Troubleshooting Hardware Problems



Warning: The GPIB-SCSI-A contains circuitry that operates with hazardous voltages. Refer service requirements to qualified personnel.

- The SCSI cable must be securely connected to the GPIB-SCSI-A.
- If the GPIB-SCSI-A is the last device on the SCSI bus, make sure that you have placed the terminating resistor pack on one of the SCSI ports on the rear panel of the GPIB-SCSI-A to terminate the SCSI bus. (See *Using SCSI Terminating Resistors* in Chapter 3, *Hardware Configuration*, for more information.)
- Check the DIP switch settings on the GPIB-SCSI-A. Make sure that they are set to the correct SCSI ID (Target ID), the correct GPIB primary address and other feature settings, such as mode of operation, data padding, or disconnection/reconnection.
 (See *Configuring the Switch Settings* in Chapter 3, *Hardware Configuration*, for more information.)
- If the **POWER** LED is not lit, check the fuse.

 \triangle

Caution: Replacement fuses must be of the proper type and rating. See Appendix A, Hardware Specifications, for fuse information.

• Make sure that the GPIB-SCSI-A is powered on.

Troubleshooting Software Problems

The NI-488 Config control panel (GPIB configuration utility) should show the following software configuration:

- The Interface Type menu selection should be set to SCSI box products.
- An **x** should appear in the ID checkbox that corresponds to the SCSI ID set by SW1 on the GPIB-SCSI-A.

Common Questions

What do I do if my box does not show up in the NI-488 Config utility?

In NI-488 Config, an \mathbf{X} should appear in the ID checkbox that corresponds to the SCSI ID of your GPIB-SCSI-A. If an \mathbf{X} does not appear in that box, make sure that all SCSI devices daisy-chained to the SCSI cable are connected properly.

What do I do if the hardware or software verification test fails with an error?

Refer to the troubleshooting sections of this chapter for information about what might cause these tests to fail.

What do I do if I have installed the NI-488.2 software and now my Macintosh crashes upon startup?

Try changing the name of the NI-488 INIT to ZNI-488 INIT. Because INITs load in alphabetical order, the ZNI-488 INIT will load last, preventing possible corruption from INITs that load after it. If changing the name of the NI-488 INIT does not solve the problem, another INIT file may have a conflict with the NI-488 INIT. Try removing some of your other INIT files. You can store them in a temporary folder, in case you need to reload them later. If you are using System 7.5 or later, you can use the Extensions Manager control panel to disable certain extensions and control panels.

My system has been crashing since I switched to a Quadra computer. What should I do?

This problem was associated with some versions of the NB Handler INIT. Upgrade to the NI-488 INIT to resolve this situation.

When should I use IBIC 488.2?

You can use IBIC 488.2 to test and verify instrument communication, troubleshoot problems, and develop your application program. For more information about IBIC 488.2, refer to Chapter 4, *Interface Bus Interactive Control Utility*, in the *NI-488.2 User Manual for MacOS*.


