

Safety Guidelines for Hazardous Voltages

If hazardous voltages are connected to the module, take the following precautions. A hazardous voltage is a voltage greater than 42.4 V_{pk} or 60 VDC to earth ground.



Caution Ensure that hazardous voltage wiring is performed only by qualified personnel adhering to local electrical standards.



Caution Do *not* mix hazardous voltage circuits and human-accessible circuits on the same module.



Caution Make sure that devices and circuits connected to the module are properly insulated from human contact.



Caution When module terminals are hazardous voltage LIVE (>42.4 V_{pk} /60 VDC), you must ensure that devices and circuits connected to the module are properly insulated from human contact. You must use the NI 9939 connector backshell kit to ensure that the terminals are *not* accessible.




Figure 1. NI 9939 Connector Backshell

Safety Guidelines for Hazardous Locations

The NI 9422 is suitable for use in Class I, Division 2, Groups A, B, C, D, and T4 hazardous locations and nonhazardous locations only. Special Conditions for Marine Applications

Some modules are Lloyd's Register (LR) Type Approved for marine applications. To verify Lloyd's Register certification, go to ni.com/certification and search for the LR certificate, or look for the Lloyd's Register mark on the module.



Caution To meet radio frequency emission requirements for marine applications, use shielded cables and install the system in a metal enclosure. Suppression ferrites must be installed on power supply inputs near power entries to modules and controllers. Power supply and module cables must be separated on opposite sides of the enclosure and must enter and exit through opposing enclosure walls.

Connecting the NI 9422

The NI 9422 has a 16-terminal, detachable screw-terminal connector that provides connections for 8 digital input channels.




Figure 2. NI 9422 Terminal Assignments

7 NI 9422 Operating Instructions and Specifications

The NI 9422 digital input channels are floating. Each channel has two terminals, DI+ and DI-, to which you can connect voltage signals. The NI 9422 measures whether the difference between the DI+ and DI- terminals is greater than or less than the digital logic levels. Refer to the *Specifications* section for more information about digital logic levels.



Note You must use 2-wire ferrules to create a secure connection when connecting more than one wire to a single terminal on the NI 9422.

The NI 9422 channel registers as ON when the external device drives a current or applies a voltage that is in the input ON range across the DI terminal. The channel registers as OFF when the device drives a current or applies a voltage that is in the input OFF range across the DI terminal. If no device is connected to DI, the channel registers as OFF. Refer to the *Specifications* section for more information about the ON and OFF states.

Connecting Sinking-Output Devices to the NI 9422




Figure 3. Connecting a Sinking-Output Device to the NI 9422

You can connect sinking-output devices to the NI 9422. A sinking-output device provides a path for current or voltage from the DI+ or DI– terminal. An example of a sinking-output device is an open collector NPN. Connect the device to the DI+ and DI– terminals on the NI 9422. Figure 3 shows a possible configuration.

Connecting Sourcing-Output Devices to the NI 9422




Figure 4. Connecting a Sourcing-Output Device to the NI 9422

You can connect sourcing-output devices to the NI 9422. A sourcing-output device drives current or applies voltage to the DI+ or DI– terminal. An example of a sourcing-output device is an open collector PNP. Connect the device to the DI+ and DI– terminals on the NI 9422. Figure 4 shows a possible configuration.

Wiring for High-Vibration Applications




Figure 5. 16-Terminal Detachable Screw-Terminal Connector with Ferrule

If an application is subject to high vibration, National Instruments recommends that you either use ferrules to terminate wires to the detachable screw-terminal connector or use the NI 9939 backshell kit to protect the connections. Refer to Figure 5 for an illustration of using ferrules. Refer to Figure 1 for an illustration of the NI 9939 connector backshell.

Sleep Mode

This module supports a low-power sleep mode. Support for sleep mode at the system level depends on the chassis that the module is plugged into.
