

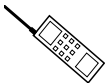

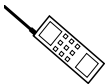

Refer to the *NI-VISA User Manual* to learn about VISA and how to use it in your system. The NI-VISA online help describes the attributes, events, and operations you can use in NI-VISA. You can find this same information in the *NI-VISA Programmer Reference Manual*. These two manuals are available in the `c:\Vxipnp\WinXX\NIvisa\Manuals` directory (where `WinXX` is either `Win95` or `WinNT`) under the names `NI-VISAUsersMan.pdf` and `NI-VISAProgrammersMan.pdf`. Use the Acrobat Reader program, Version 3 or later, to open these files.

PXI-8156 users receive the NI-488.2M software kit, which includes the *NI-488.2M User Manual for Windows 95 and Windows NT* and the *NI-488.2M Function Reference Manual for Win32*. PXI-8155 users can get this kit by ordering a PXI-GPIB interface module.

If you ordered either LabVIEW or LabWindows™/CVI, you receive full documentation along with a configuration disk to unlock and access these application programming environments, which are already installed on your hard drive.

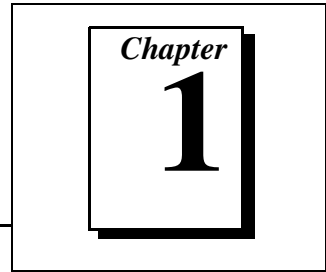

Introduction



This chapter describes the PXI-8150 Series of embedded PXI computers, lists what you need to get started, lists optional software, and gives an overview of the directory structure on your hard drive.

What You Need to Get Started

- PXI-8150 Series embedded controller
- PXI bus mainframe
- Keyboard (and included adapter cable)
- Serial or PS/2 mouse
- Monitor with VGA or better resolution

Hardware Description

The PXI-8150 Series are 3U-size embedded PXI computers based on the Peripheral Component Interface (PCI) bus and Industry-Standard Architecture (ISA). These embedded computers are high-performance, easy-to-use platforms that take advantage of the PXI high-performance backplane capabilities to control PXI systems. These embedded computers.

All models in the PXI-8150 Series are compatible with PC-compatible software tools, the National Instruments LabVIEW and LabWindows/CVI application software, and the NI-VISA, NI-488.2M, and NI-DAQ driver software.

For in-depth details on the PXI-8150 hardware, consult the *PXI-8150 Series User Manual*.

Software Description

National Instruments has developed several software kits you can use with the PXI-8150 Series. The software is already installed on your hard drive.

You can use the NI-VISA high-level API to program GPIB, Serial, parallel, and PXI devices in much the same manner. The NI-VISA kit includes installation disks you can use if you need to reinstall the software, and the *NI-VISA User Manual*.

The NI-488.2M software kit is the industry standard for controlling external GPIB instruments through the GPIB port on the PXI-8156 front panel. The software is already installed on your hard drive, and you also receive backup installation disks and the *NI-488.2M User Manual for Windows 95 and Windows NT* and the *NI-488.2M Function Reference Manual for Win32*.

The GPIB interface is fully compatible with the NI-488.2M driver for a variety of operating systems. Any software using NI-488.2M will run on the PXI-8150.

National Instruments Application Software

You can use the National Instruments LabVIEW and LabWindows/CVI application programs and instrument drivers to ease your programming tasks. These standardized programs match the modular virtual instrument capability of PXI and can reduce your application development time. These programs are fully *VXIplug&play* compliant and feature extensive libraries of GPIB, Serial, and VXI instrument drivers written to take full advantage of direct PXI control. LabVIEW and LabWindows/CVI include all the tools needed for instrument control, data acquisition, analysis, and presentation.

LabVIEW is a complete programming environment that departs from the sequential nature of traditional programming languages and features a graphical programming environment.

LabWindows/CVI is an interactive C development environment for building test and measurement and instrument control systems. It includes interactive code-generation tools and a graphical editor for building custom user interfaces.

If you ordered LabVIEW or LabWindows/CVI, you received a configuration disk to access either or both of these application programming environments. Refer to Chapter 2, *Setup*, for more information. You also received all the necessary libraries to support your PXI-8150 and hundreds of complete instrument drivers, which are modular, source-code programs that handle the communication with your instrument to speed your application development.

Files and Directories Installed on Your Hard Drive

Your hard drive includes a directory called `images` in its root that contains software and soft copies of manuals for the operating system and peripherals. The directory structure under the `images` directory is logically organized into several levels.

In the `images` directory itself, you will find a `manuals` directory, an `os` directory, and directories for each of the peripherals of your computer.

The `manuals` directory contains quick reference guides, technical reference manuals, and National Instruments software manuals, all in Adobe Acrobat format. To access any of these manuals, change your directory to `c:\images\pxi815x>manuals` and list the contents of that directory. You will see several files, one corresponding to each peripheral.

The `os` directory contains a subdirectory corresponding to the operating system installed on your computer. That subdirectory contains an image of the CD from which your operating system was installed, so you do not need to insert the CD when you install a new peripheral. When the software prompts you to insert the CD, simply direct the system to look in the `images\os` directory instead.

For example, if your system has Windows 95 installed, you should find an image of the Windows 95 CD in `c:\images\os\win95`.

The rest of the directories correspond to each of the peripherals in your system. Within each of these directories are the drivers for the peripherals. These files and directories are copied exactly from the distribution disks of the manufacturers, so the naming conventions vary from peripheral to peripheral.

Because the naming conventions may not be completely straightforward, National Instruments provides a text file named `drivers.txt` in the `c:\images\pxi815x` directory. The `drivers.txt` file explains how to install support for each peripheral. You may want to print this file for reference when you install your peripheral device drivers.

This chapter contains basic instructions for setting up the PXI-8150 embedded computer.

You can use this material as a guide to quickly configure and operate your PXI system using the PXI-8150. This chapter assumes that you intend to perform a basic configuration as follows:

- You have one PXI mainframe in which you will be using the PXI-8150.
- You will use the default settings.

Refer to Appendix A, *Default Settings*, for a complete listing of the default settings. If you need more information, or if you want to try a different configuration, please refer to the *PXI-8150 Series User Manual* for information about the hardware, or to the National Instruments software manuals you received with your kit.

Hardware Installation



Caution: *To prevent electrostatic discharge, touch the antistatic plastic package to a metal part of your PXI mainframe before removing the PXI-8150 from the package.*

1. Plug in your mainframe before installing the PXI-8150. The power cord grounds the mainframe and protects it from electrical damage while you install the module.



Warning: *To protect both yourself and the mainframe from electrical hazards, leave the mainframe off until you finish installing the PXI-8150 module.*

2. Remove or open any doors or covers blocking access to the system controller slot (Slot 1) in the mainframe.
3. Make sure the injector/ejector handle is in its downward position. Align the PXI-8150 with the card guides on the top and bottom of the system controller slot.



Caution: *Do not raise the injector/ejector handle as you insert the PXI-8150. The module will not insert properly unless the handle is in its downward position so that it does not interfere with the injector/ejector rail on the mainframe.*

4. Hold the handle as you slowly slide the module into the mainframe until the handle catches on the injector/ejector rail.
5. Raise the injector/ejector handle until the module firmly seats into the backplane receptacle connectors. The front panel of the PXI-8150 should be even with the front panel of the mainframe.
6. Tighten the four bracket-retaining screws on the top and bottom of the front panel to secure the PXI-8150 to the mainframe.
7. Check the installation.
8. Connect the keyboard and mouse to the appropriate connectors. Use the keyboard adapter cable that you received with your kit if you need to adapt an AT-style keyboard to the PXI-8150 mini-DIN connector.
9. Connect the VGA monitor video cable to the VGA connector.
10. Connect devices to ports as required by your system configuration. Some ports, such as the Parallel port, have adapter cables that you can order from National Instruments.
11. Replace or close any doors or covers to the mainframe.

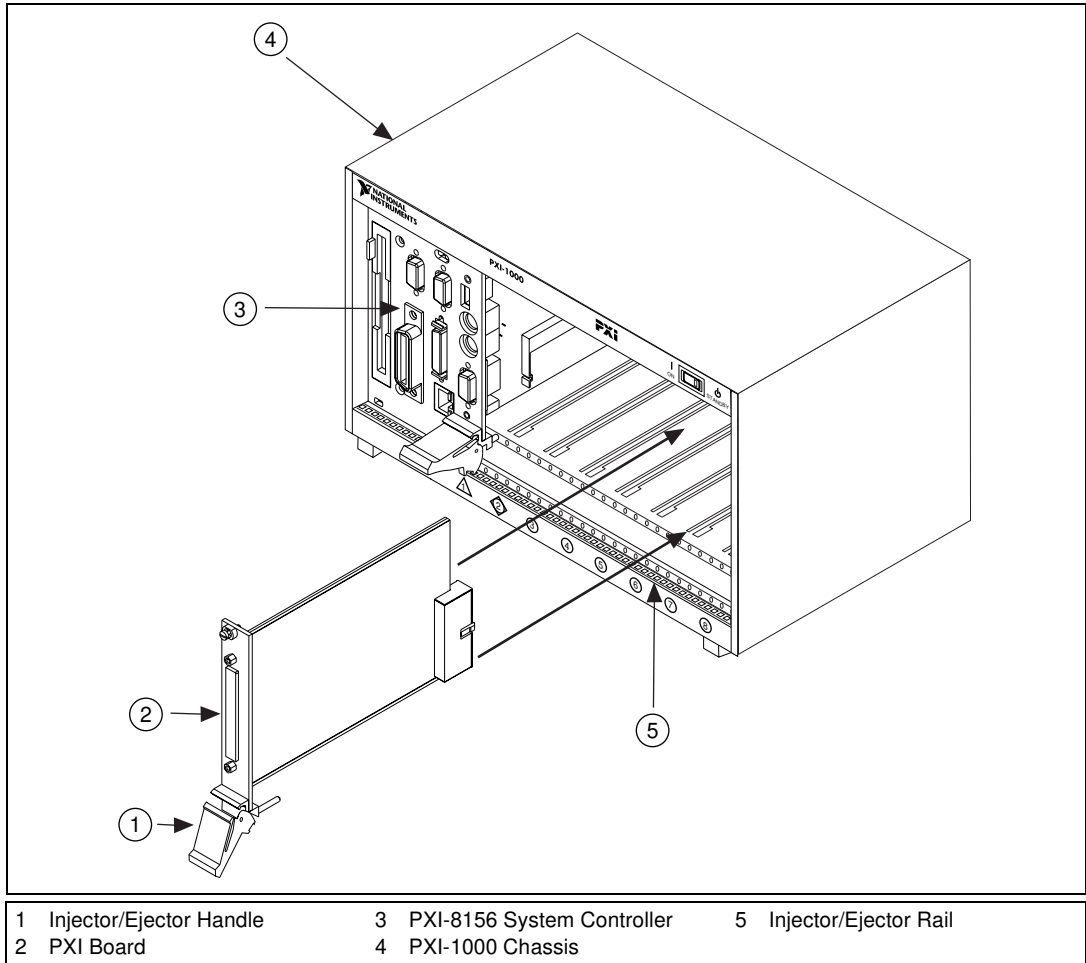


Figure 2-1. PXI Mainframe and Controller

Figure 2-1 shows a PXI-8156 installed in the system controller slot of a National Instruments PXI-1000 mainframe. You can place PXI devices in any of the peripheral slots, which are numbered 2 through 8.

Setting up the PXI-8150

At Windows 95/NT startup, the software prompts you to insert a disk to configure the system for LabVIEW or LabWindows/CVI, and to enter the serial number for the operating system. These programming environments are already installed on your system but you must insert a configuration disk when prompted so that you can access and use them. If you ordered either of these programming environments, select

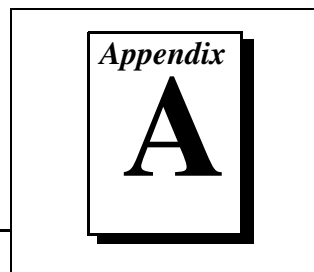
the appropriate checkbox and insert the configuration disk. Follow the instructions as prompted.

Do not select either checkbox if you did not order LabVIEW or LabWindows/CVI. Continue with the rest of the Setup program.

The PXI-8150 comes with the NI-488.2M and NI-VISA software already installed. However, if you need to reinstall NI-VISA in the event that your files were accidentally erased, use the Setup program and follow the prompts to install these programs from the diskettes. The PXI-8156 kit also includes backup disks for NI-488.2M.

Similarly, if you need to reinstall LabVIEW or LabWindows/CVI, use the CD or diskette package that came with these programs.

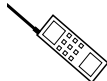
